TITLE "THE WAY WE WERE"

SITE 1

Wing Of Desire

Approx- 3000 bottles-labels off

The wing will stand as a tribute representing the freedoms we are living each day.

Created out of recycled materials, Use of phosphorescent s (materials that glow in the dark)

Wing will be created through a metal fabricated armature that acts as a Kinetic sculpture moving with the natural rhythm of the wind. The body of the sculpture will be a combination of recycled bottles and materials. Led Lights will be used to accent the glow of each matriculated layer. Wing Size estimate: 10 ft tall by 15 ft wide

Annual Wish in a bottle:

Asst. w/labels Approx. -1500 labels Annual Wish in a bottle: Each visitor will be able to make a wish and place it in one of the recycled bottles freestanding mobile style creating

A natural rhythm and progression Recycled materials. Visitors will be greeted and educated on the exhibition and asked to participate in the wish in a bottle project

WE ROCK- SCULPTED 12 X 8 GUITAR

Interactive We Share/ Care interactive Exhibit

Custom fabricated ELECTRIC GUITAR acts as a welcoming symbol to the fair.

Site 4

Matrix- Recycled repurposed Electronic based sculpture August 2011

A large-scale installation combining discarded televisions and additional technology thrown away by society in favor of a new shiny replacement. The Matrix exhibit will focus on the consumption of mass media as an industry and the tools and materials utilized to share the messages of society as a-whole.

What happens when a fully functioning display is abandoned? Matrix is video sculpture created from the abundance of free CRT televisions that are being tossed in favor of flat- panel displays.

Mannequin installation created from 10 discarded figures representing human interaction.

Each Mannequin has been recreated as work of art and will be on display for photo opportunities and community interaction. Mannequins represent one figure for each year since the 911 tragedies.
