Dear Ms. Renna and Mr. Paterson:

In your letter dated October 3, 2011, you purport to respond to charges that you have not defamed Netta Architects, LLC and Nicholas J. Netta, AIA, NCARB (collectively, "Netta"). Yet in that letter, you make no attempt whatsoever to even try and provide any factual basis for those defamatory statements and insinuations. Rather than defend the truthfulness of your allegations, you instead devote the entire response to requesting information purportedly to assist you in the proverbial witch-hunt now being directed at former County Manager George Devaney as cited in your explanation. Whatever information you are seeking about Mr. Devaney, that information has no impact on your failure to continue to publish untruthful accusations that Netta "does not know how to build court building," that he "admitted he didn't know the court requirements," or that he "tripled his fee because of some miscalculation [he] made." Your response simply demonstrates that you have no factual basis to make allegations against Netta, only speculation, and that you thrive on rumors and half truths to propagate damaging innuendo, misinformation and propaganda. Kindly be forewarned to move with caution unless you are prepared to defend the veracity of the defamatory statements in the appropriate legal forum.

While your letter supports and can only be taken as an acknowledgment that your statements about Netta were recklessly or intentionally false, your continued failure to remove the defamatory statements is inexcusable. You are on notice that Netta has been damaged by your false statements, and should you fail to remove such video and statements from your Union County Watchers blog page and the You-Tube which credits Union County Watchdog Association for the upload, it will continue to be damaged. Anything other than immediate compliance with the demands set forth in our September 28, 2011 letter will be deemed unsatisfactory.

Please be further advised that this letter is being sent without prejudice, and Netta reserves the right to pursue any and all remedies for the defamatory statements you have made, including statement not explicitly referenced in this letter. No further communication shall be forthcoming without the guidance by the courts.
