AN ORDINANCE FIXING THE SALARIES OF  
 COUNTY OFFICIALS AND DEPARTMENT HEADS AS AMENDED

BE IT ORDAINED by the Board of Chosen Freeholders of the County of Union as follows:

Section 1. The salaries of the Freeholders, Chairman and Vice-Chairman shall remain unchanged as established as of January 1, 2007.

Section 2. The salaries of the County Manager, Deputy County Manager and the following Department Heads shall be as hereinafter set forth. The same shall be effective as of January 1, 2007 or as of appointment date.

Section 3. That this Ordinance shall take effect at the time and manner provided by law.

Section 4. That the Clerk of this Board be and she is hereby authorized to publish a notice in the appropriate newspaper of such introduction and of a public hearing on December 20, 2007, and shall forward one certified copy of final passage, to each Clerk of all Municipalities located within the County of Union.






